

The selection shall be on the basis of Career mark and Interview as per Govt. guidelines.

Conditions of Service

The contractual staff will be appointed with following terms and conditions-

1. Service of contractual staff is purely temporary and terminable at any time without assigning any reason thereof.
2. He/She will be appointed for 89 days.
3. There will be one day break after every 89 days and again they will be reappointed for another 89 days.
4. He/She will be terminated with the start of Summer Vacation (it is not applicable to DEO.)
5. Under no circumstances he/she will be reappointed in Summer Vacation (it is not applicable to DEO.)
6. The contractual employee will work without any right to permanent appointment or regularization or equal treatment like any regular employee of the college.
7. He/She will be terminated by one month notice if his/her performance is found not satisfactory.
8. He/She has to submit 2 undertakings as per annexure- I & II.
9. He/She will discharge any additional duty assigned to him/her in exigencies in the interest of the college.
10. A contractual lecturer shall be paid Rs. 5,000/- as monthly consolidated remuneration and DEO shall get Rs. 6,000/- as monthly consolidated remuneration.

N.B- No TA/DA will be paid for attending the interview and the undersigned reserves the rights to cancel, modify the advertisement, walk-in-interview and the service conditions if necessary.
